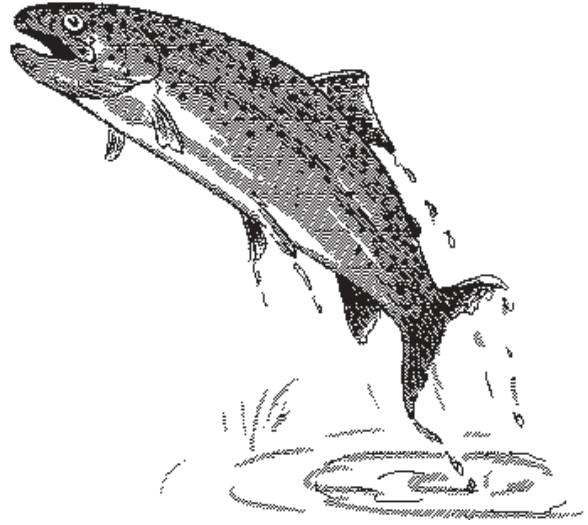

March Program

Our March program will feature two of the most famous folks in ETU -- Colorado's First Lady of Flyfishing, Karen Christopherson; and noted photographer and outdoor writer, Al Marlowe -- doing a presentation entitled *Fifty Colorado Tailwaters*. Yes, you read correctly, join us on March 17th at the Evergreen Hotel to learn all about FIFTY different Colorado tailwaters! ETU is pleased to present two of the most knowledgeable people on flyfishing in Colorado and the surrounding area.

Karen Christopherson is known by thousands as the webmaster of two of the best flyfishing sites on the web: coloradofishing.net and wyomingfishing.net. The responsibility of being a webmaster has allowed her the opportunity to fish many unique rivers, and answer lots of strange questions from readers. A fly fisherwoman since age 17, she has fished throughout the west and in numerous exotic international locations.

Al Marlowe is an extensively published author and photographer, with over 100 articles appearing in magazines which include: *American Angler and Fly Tyer, Backpacker, and Outdoor Photographer*. He has also written three books: *Fly Fishing the Colorado River; An Angler's Guide, A Hiking and Camping Guide to the Flat Tops Wilderness Area, and Fly Fishing the Flat Tops*.

Karen and Al's presentation will be based on their newly released e-book which is available on CD. They have combined their extensive knowledge and talents to produce a very exciting guide which provides information on 50 selected tailwater fisheries, from the well-known like the Frying Pan and South Platte to small, out of the way, lesser-known streams that offer a wide variety of angling. In addition to locations, information is presented on when, where, and how to fish Colorado's tailwaters. Each of the fifty tailwaters is described for size, location, specifics as well as a full-page map.

Lawsuit Threatens Salmon Protection

Agribusiness interests and developers are suing to overturn ESA protection for steelhead in the Willamette and Columbia rivers, a lawsuit that if successful "could bring about the end of federal safeguards for 26 stocks of Pacific salmon," says the Oregonian 3/5. The case signals a renewed wave of challenges following affirmation last week of a 2001 court ruling on Oregon coast coho, which ordered the NMFS to reconsider the role of hatchery fish in determining whether salmon warrant ESA protection. Similar lawsuits are challenging listings of salmon in Puget Sound, Oregon's south coast and California, potentially jeopardizing "one of the nation's largest and most costly species recovery efforts" and habitat protections for much of the Pacific Northwest.

CWQCC Denies Bear Creek Listing Upgrade

In hearings before the Colorado Water Quality Control Commission, held March 9th and 10th, CTU and ETU presented their testimony for upgrading Bear Creek's status to the 303(d) 'impaired' waters list. The listing process is rather lengthy, governed in part by the US Clean Water Act. Bear Creek was one of two segments presented by Melinda Kassen and Dave Nickum of CTU (the other segment being the Dolores River, below McPhee Reservoir).

Bear Creek is currently listed on the 'Monitoring and Evaluation' list. CTU/ETU presented evidence for upgrade to the 'impaired' list based primarily on temperature as a pollutant. We had the backing of the EPA, DOW, and the CWQCC staff. Impaired status would have meant that efforts would be required to maintain the stream at temperatures of 20C or less. Some of the mitigation could have involved reducing temperatures of the recharged effluent (from Evergreen Metro District, Kittredge, and others) and/or shading or other stream improvements to help reduce temperature.

However, on Wednesday, the Commission voted not to upgrade for Bear Creek to impaired status. The EPA can challenge the Commission's decision. We will know more about this in the coming weeks. And we will continue our temperature monitoring program (started in 2001) to provide evidence for future hearings. Also, ETU has been invited to participate in Evergreen Metro District's monitoring program and meetings -- they have also been monitoring stream temperatures for the past two years.

We will keep you up to date as this process continues...

New Water Quality Standards For OR

Oregon has issued new EPA approved water-quality standards for every fish-bearing waterway in the state in order to better protect endangered salmon and trout says the Salem Statesman Journal 3/3. The new standards defining "optimal water temperatures depending on time of year and waterway" and discharges from both point and nonpoint pollution sources are the result of a lawsuit by Northwest Environmental Advocates of Portland which successfully argued that the 30 year-old standards failed to meet the requirements of the Clean Water Act and ESA.

Rangeland Protection Eased

Ranchers are "cheering" plans by the Bush administration to relax environmental protection from grazing on some 160 million acres of BLM lands says the Denver Post 2/10. The new grazing regulations would take effect as early as December and require the BLM to document damage from livestock before changing lease terms, reduce public participation in decision making and "eliminate the public's ability to challenge agency findings on endangered-species issues." A BLM draft EIS admits that the new rules would "do little to promote recovery of damaged streamside vegetation or to stem declines of potentially endangered plants and animals."

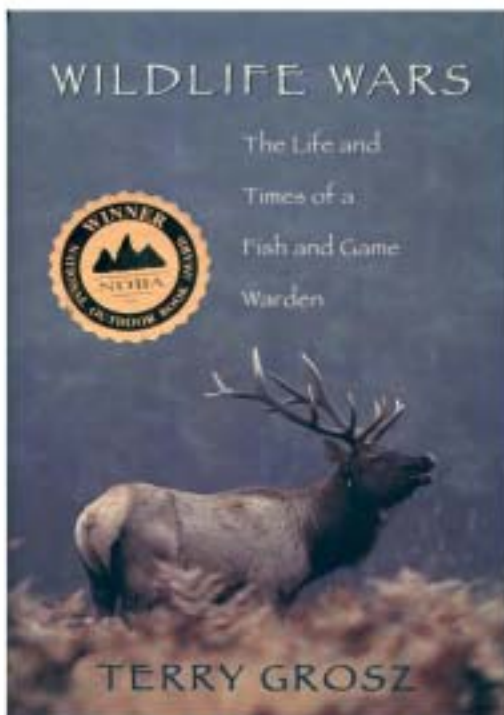

Evergreen Trout Unlimited is the local chapter of a nationwide non-profit conservation organization. Trout Unlimited is North America's leading coldwater fisheries conservation organization, dedicated to the conservation, protection and restoration of trout and salmon fisheries and their watersheds. We have more than 130,000 members in 450 chapters in North America.

We are contacting you today to let you know about an exciting endeavor that we have planned for this year. In addition to our many other community activities, we have committed to do a major stream improvement project on Bear Creek in O'Fallon Park, near Kittredge. The project will include creation of overwintering trout habitat, stabilization of eroding banks, narrowing the overly wide channel, revegetation, and will provide easily accessible fishing access points. The total cost of the project is \$183,700, for which we have received a \$119,400 Fishing Is Fun grant from the Colorado Division of Wildlife.

ETU Community Activities

Bear Creek - As self-proclaimed "River Keepers", we do stream cleanups two to three times per year. We also monitor stream temperatures and flows, and work closely with local water agencies and users to maintain flows and water quality. We are currently petitioning the state to effect long term monitoring of many stream variables. We've also completed many stream improvement projects over the years. This Fall's O'Fallon Park project will be our biggest yet.

Mount Evans Outdoor Lab School - We assist the school (for Jefferson County 6th graders) in various fishing/aquatics related functions throughout the year, including fly tying/entomology classes, native fish programs, and maintenance of several aquariums. We also cook and serve food at their annual Open House to raise additional money for the school, and we assisted in the construction of a new pond by building the handicapped access fishing pier there.

Fishing Clinics/Education - We annually host or help with numerous fishing clinics including: The Evergreen Lake Fourth of July Fishing Clinic for Kids, similar clinics at Georgetown Lake and elsewhere in the state, the Evergreen Park and Recreation District's summer fishing program for kids, the Mount Evans Hospice Camp Comfort for kids at Santa Maria, and more. We assist with the very successful and educational Trout in the Classroom program at local elementary schools. We also participate in the Evergreen High School Community Service Day, Earth Day, Scouts, and other community events.

Donations - We've donated money to different scholarships, Colorado Division of Wildlife (for Whirling Disease Research), Colorado Trout Unlimited (for various statewide projects), the Mountain Area Land Trust (MALT), and others.

Miscellaneous - We hold monthly meetings (open to the public) with updates on local activities, stream work, and water issues, and then have a program featuring a speaker on fish, wildlife, and the environment.

TU's Recommendations For Hatchery Reform

Know The River Ecosystem

Managers should have a robust understanding of the ecological landscape and its components that will host any hatchery. This includes the historic and current species present, at least some knowledge of the genetic composition of the species directly impacted by the hatchery, the carrying capacity of the freshwater, estuary and ocean environs, the nutrient cycle and food web dynamics, among other basic biological information. The use and type of hatchery will be dependent on the known landscape, its needs and the needs of the people who use the watershed and its products.

Work Within The Context Of That River's Landscape

All hatcheries should be managed in the context of the watershed and ecological landscape in which they operate. Production should be metered to the capacity of the watershed and the overall river system, including the estuary and ocean productivity. Hatcheries should contribute to, or at the very least not disrupt, the ecological structure and function of the watershed in which they are located.

Raise The Right Fish

The genetics and other biological attributes (including life history and behavior) of the fish released should mirror the genetics of the wild populations of the watershed unless doing so poses a greater threat to the wild population. Hatchery operations should be directed at achieving "effective population size" as opposed to pure numbers, with particular attention paid to family cohorts. ("Effective population size" means that the population has the requisite diversity to avoid genetic bottlenecks. Thus, a population of 2,000 fish that are closely related -- siblings or cousins -- may not be as healthy as a population of 500 fish with more diverse

family groups). Further, the hatchery genetic operations should not alter the genetic structure of the wild populations except in rare, intentional situations that are strategically implemented under the strictest biological monitoring regime, such as captive broodstock programs.

Mimic The Natural Landscape

Operations "inside the hatchery fence" should mimic natural systems as much as possible. In addition to making raceways more closely resemble natural streams, it means strategically locating hatcheries depending on the landscape and management needs, using local broodstock, meaning from the same stream and even geographical reach where the hatchery is located, raising fewer fish, replicating natural nutrient and temperature cycles and cues, and staging releases to mimic natural processes.

Be Economical: Reduce And Eliminate Harmful And Wasteful Practices

All hatcheries, especially production hatcheries, that are in conflict with the Endangered Species Act and wild fish should find a way to operate with minimal to no adverse impact on wild fish and within the landscape model. If it is not possible to modify these hatcheries, then managers should consider moving the hatchery operations to more appropriate watersheds, and if not possible, then they should close. Funding for closed and restricted hatcheries should be shifted to provide more support for watershed scale hatcheries that assist in the recovery of native stocks, and for habitat restoration that allows for salmon abundance through healthy watersheds.
