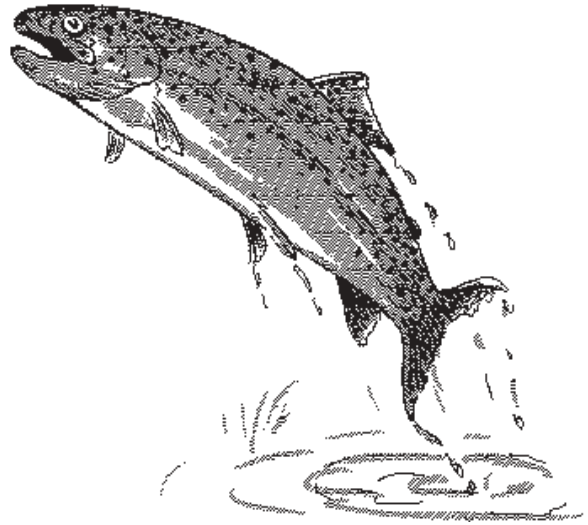

February Board Meeting

Discussion of upcoming programs, with plans to continue the focus on local area fishing opportunities. The initial fly-tying demonstration by Tim Haller at the January meeting got a good response and will be continued, with equipment on hand for people to tie the flies being demonstrated.

The John Fielder event originally scheduled for last fall now will be offered in November if that date works with John. This also will be ETU's major fundraising event for the year.

The O'Fallon Park stream restoration project is complete except for editing of a video documenting the project and the construction and installation of the kiosk that will illustrate what was done and what trout may be caught. The target date for completing both is late April or early May. Until those pieces of the project are completed, ETU will not be able to get state reimbursement for all expenditures, meaning ETU's finances will be tight, but manageable, until then. A spring cleanup of the O'Fallon Park project area will be held in late April. The effort will target noxious weeds that may be coming up along the stream bank.

Len Wheaton reported that the next fly-tying class for students at the Mt. Evans Outdoor Lab is set for May 4. Volunteers welcomed. Call Len at 674-4243.

Hugh Gardner reported that the state is holding hearings on fishing regs, including along Bear Creek, on March 10th and 11th. Hugh will follow up to see who needs to attend from ETU. Hugh also reported that there is no ruling yet from the EPA on whether to list Bear Creek as an impaired water. Hugh and John Haile will meet with Evergreen Metro District about the Bear Creek issues, including an offer of ETU's support in opposition to a developer's plans to use water in upper Bear Creek for a housing project. Water rights from the Turkey Creek area are being offered by the developer in exchange, but the project would reduce the already often-critical water flow in lower Bear Creek.

John Ellis and Len Wheaton were named to coordinate youth programs for the chapter.

Mike Goldblatt will coordinate chapter outings. The first ETU fishing outing is being scheduled for late April or early May on the Arkansas River. Details will be announced shortly. Other outings already are being considered, including Clear Creek and Bear Creek.

The fundraising relationship with Beau Jo's is off to a good start, with about \$150 coming back to ETU from the January and February meetings. The chapter gets back 20% of all purchases at the regular chapter and board meetings. Beau Jo's will soon make available an ETU discount card with 10% off all purchases at any time, with another 5% coming back to ETU. Beau Jo's also will be a sponsor for the July 4th fishing clinic at the lake and for certain other ETU youth projects.

Ken Wilbert and John Ellis will finalize plans with Evergreen Park and Recreation District for an early summer youth clinic at Buchanan Pond. They also are exploring an additional ETU free fishing day at the pond each month, possibly on weekends.

The board agreed to put together a nice fly box with several dozens flies tied by chapter members for the Colorado Trout Unlimited auction in March. Tim Haller is coordinating.

Annual WD Conference Offers Hope

This February, the Whirling Disease Foundation hosted the annual Whirling Disease Symposium at the Brown Palace in downtown Denver. CTU was a contributing sponsor for the symposium, which brought together more than 100 top researchers and managers from throughout the United States and beyond to present the latest findings on whirling disease.

Among the more intriguing findings reported at the symposium were promising results with disease resistance in certain strains of rainbow trout and of *Tubifex tubifex* worms (the worms are the alternate host for whirling disease and produce the spores that infects fish). It appears that certain strains of worms are more resistant to the disease, and that they may out-compete and displace the more susceptible worms -- a possible "bio-control". Work is also underway on resistant trout strains, including an effort in Colorado to cross "Hofer" strain rainbows -- a highly domesticated strain that is very resistant to whirling disease -- with some of Colorado's wild rainbow strains in the hopes of lending resistance to our susceptible wild rainbow strains. While such resistance is not a panacea -- for example, it doesn't help our unique native stocks of cutthroat trout -- it could help restore reproducing stocks of rainbows to WD infected waters like the Gunnison and Colorado Rivers. CTU will continue to support whirling disease research and help in the battle against this deadly trout disease.

CDOT Seeks Comments On I-70 Corridor

The Federal Highway Administration and the Colorado Department of Transportation (CDOT) issued a Draft Programmatic Environmental Impact Statement for future development of the Interstate 70 mountain corridor. The EIS identifies nine preferred alternatives ranging from development of a six-lane highway in different configurations, to use of a dual mode or diesel bus for transit. Mass transit options (i.e., rail or "advanced guideway system") were dismissed from consideration as too costly -- denying the opportunity to fully evaluate such options and their social and environmental costs vis a vis the more traditional options that were identified as "preferred".

CTU's major interest in the I-70 plan is the implications for habitat and water quality of streams effected by the highway development -- specifically, Clear Creek, the Blue River (and tributaries such as Straight Creek), and the Eagle River (and tributaries such as Gore Creek). Earlier in the EIS process, the CDOT convened a group under the "SWEEP" initiative -- Streams and Wetland Environmental Enhancement Program. CTU was ably represented in that effort by Gary Frey, Resource Chairman for the West Denver Chapter. The SWEEP process was intended to help identify mitigation needs and policies for the EIS but was abruptly terminated by CDOT before it was allowed to complete its mission, severely limiting the EIS' ability to responsibly address aquatic and wetland concerns.

The EIS also fails to adequately address the cumulative impacts of proposed and past actions -- impacts which are already substantial and are revealed in problems such as major sedimentation along Straight Creek (and into the Blue River) and Gore Creek, and limited fisheries in highway-impacted portions of Clear Creek. Water quality is a major concern. The aforementioned reaches as well as others like Black Gore Creek have been significantly degraded due to the massive amounts of traction sand applied for winter maintenance which, in turn, washes into and eventually clogs the streams with sediment. CDOT's mitigation measures are designed to recover somewhere between 25 and 80 percent of the sand applied -- meaning that tons and tons of sand will continue to wash into streams each year, worsening an already serious problem.

The EIS also does not address the presence of greenback cutthroat trout in the Clear Creek drainage near the Eisenhower Tunnel. Different options may have different implications for the existing greenbacks, as well as for the potential of Clear Creek to support a restoration project that could expand their range. This issue is not only about the threat to greenbacks of different alternatives, but about the opportunities for some excellent native trout mitigation efforts -- should CDOT choose to engage them. At this point, the EIS is silent.

Through comments and at public hearings, CTU is calling on CDOT to better address aquatic habitat concerns in the EIS process and to more openly consider a full range of alternatives. To assist in that effort, we have urged CDOT to reconvene the SWEEP process and let it complete its work and feed into a revision of the programmatic EIS.
